You are scheduled for a biometric services appointment at an Application Support Center (ASC). Please note the following:

Application Support Centers (ASC) offer biometrics collection services by appointment.

You must have a scheduled appointment before arriving at an ASC.

USCIS will provide specific instructions on what you should bring to your ASC appointment. You must also bring:

A printed ASC appointment notice (Form I-797C).

A recent color photograph identification (such as your Green Card, passport, or driver's license)

A completed Applicant Information Worksheet (AIW) below

If you have received multiple biometrics appointment notices, please bring all notices to your appointment.

Interpreters, attorneys or those providing needed assistance if you are disabled are permitted to accompany you.

Family members may appear together, even if they are scheduled for a different day.

Family members may appear without an appointment.

You must arrive more than 15 minutes before your appointment. you may be asked to wait until your appointment time to be processed.
